CHEERLEADER/MASCOT TRYOUT INFORMATION

2018-2019

Attached you will find all of the necessary information for a student interested in trying out for cheerleader and mascot for the GOHS cheer program. Changes may be made to the constitution after the head coach has been selected. Keep this copy of the constitution for your records. All rules and regulations as stated in the constitution, as well as the AACCA, NFHS Spirit, and UIL guidelines, will be followed carefully. You will need to read and to understand every page before making your decision to try out for cheerleader/mascot.

The **Cheerleader/Mascot Application, Constitution Agreement, Medical Release Form, and Varsity Agreement** must be turned into the Front Office at Oak Ridge High School or room B218 (Coach Sarah Ellison) on the senior campus no later than the end of the school day on **March 5, 2018**. Failure to do so may result in a disqualification from tryouts. There will be a **Mandatory Pre-tryout Meeting** before tryouts on **Tuesday, February 27, 2018, at 5:00 p.m.** in the **Cafeteria**. **ALL candidates and a parent/guardian** must be in attendance in order for the applicant to tryout. If there is a crisis and you will not be able to attend the meeting, then you must arrange a conference with Coach Ellison **before March 5, 2018**, in order to discuss the information presented at meeting. The Tryout Clinic and Tryouts will be held at Oak Ridge High School. The **Tryout Clinic** will be held on **March 5th–March 7th from 4:30 p.m. until 6:30 p.m.** **Tryouts** will be held on **March 8th**. All candidates must attend **all three clinic days and must be counted present in school all days** during the Tryout Clinic week, including the day of tryouts.

- *Cheerleader/Mascot Application **due March 5th**
- *Constitution Agreement **due March 5th**
- *Signed tryout medical release form for tryouts only: **due March 5th**
- *Copy of birth certificate if not on file at GOHS (8th grader/new) **due March 5th**

Constitution Agreement

I have received, read, and understand the Cheerleader/Mascot guidelines and procedures. My signature below indicates my agreement to adhere to all the guidelines and procedures outlined. I also understand that the guidelines are not all inclusive and that the coach and/or administration may impose additional guidelines and procedures. Each cheerleader/mascot will receive an addendum to the guidelines and procedures as they are made. I am also aware that in the event of a safety issue, the cheer coach may implement a guideline or procedure so the cheerleaders/mascots are safe.

I am aware that the expenses involved in cheerleading can surpass \$1000.00 at the high school level (including camp wear, uniforms, shoes, camp cost, fundraisers, etc.). I further understand that all expenses (camp and clothes) must be paid prior to camp, according to the dates set by the coaches. I agree to pay the expenses involved in this sport by the due dates, unless other arrangements have been made. If the coach has allowed a payment plan for the expenses, I agree to follow the plan or the cheerleader/mascot will be suspended until the accounts have been cleared. If the account is not cleared by the next tryout, the cheerleader/mascot will not be able to try out for the following season and can even be removed from the team if the debt is not taken care of in a timely manner. If the cheerleader/mascot is a senior, she/he will not be able to graduate until the fines are cleared. I am also aware that the freshman and junior varsity teams must maintain enrollment in a tumbling class at Woodlands Elite on his/her own.

I understand that cheerleading is a time-consuming activity, and that if my son/daughter makes the squad, cheerleading activities must take priority. I understand that in order for a non-cheerleading, school-related, or non-school related event to be excused, the coach must be notified **no less than two weeks** in advanced. Permission to miss a non-school or cheer related event will not be guaranteed.

If I am benched, I understand that I have to abide by the same rules as the cheerleaders who are not benched.
